1. केवल Notified kind of variety (C/S, T/L, F/S, B/S) का ही नमूना लिया जाय।
2. प्रपत्र-5 सही ढंग से भरा जाय तथा यह प्रपत्र केवल आधिकारिक नमूना के लिये ही प्रयोग करें।
3. सर्विस नमूना मात्र सूचीबद्ध करके भेजा जाय। इसके साथ प्रपत्र-5 का प्रयोग नहीं करें।
4. सर्विस नमूने के लक्ष्य को प्रखंडवार विखंडित करते हुये प्रखंड कृषि पदाधिकारी/कृषि समन्वयक के माध्यम से यदि प्रत्येक पंचायत से एक भी नमूना का संग्रहण किया जाय तो इस लक्ष्य की प्राप्ति आसानी से हो सकती है।
5. सहरसा, भागलपुर एवं मोतीहारी बीज जाँच प्रयोगशाला में निकासी शून्य है।
6. भागलपुर का 38 नमूना (गेहूँ), बाँका का 1 नमूना (राई/सरसों), बक्सर का 1 नमूना (बाजरा) एवं भोजपुर का 1 नमूना (चना) अमानक हुआ है। विश्लेषण प्रतिवेदन संबंधित निरीक्षक को भेजा जा चुका है।
